Item 3: Approval of Minutes

Item 4: Operations Report

 The MPLIDAB was updated on tennis court reopening, basketball court hoops remaining closed because of state prohibition on contact sports, winterization of outdoor water systems, and recent removal of dead trees.

Item 5: Old Business

- OPRD Local Government Grant Metzger Park Sport Court project
 - The project complete. All new areas and amenities will be open to the public, but the basketball hoops will remain covered until the state's Covid-19 restrictions allow reopening. No firm timeline for reopening.

Budget Review

 The MPLIDAB reviewed the annual budget including the money set aside for capital replacement items.

Capital Replacement

o Information on scope and cost of roof replacement and capital replacement of the heating/cooling systems was provided to the MPLIDAB. There was a thoughtful discussion about the projects and their cost. Washington County's HVAC supervisor, Operations Maintenance Supervisor, and Facilities and Park Services contracting analyst provided information to the MPLIDAB about the bidding process, the bid package, and the scope of work for replacing the hall roof and heating and cooling system in the hall. After the robust deliberation the MPLIDAB unanimously passed a motion to spend up to \$18k on the HVAC system replacement (splitting total cost with County), and up to \$66,500 to replace the existing roof with a metal roof. These funds are currently available in the LID fund to expend.

Item 6: New business

- MPLIDAB appointment/reappointments
 - The MPLIDAB recommended Holly Weick and Darlene Dick for voting member seats. This recommendation will be taken to the Board of County Commissioners, and with their concurrence, new members will be appointed/reappointed.
- MPLIDAB 2021 meeting schedule
 - The MPLIDAB set their 2021 meeting schedule for quarterly meetings starting in January 2021.
